## York council raises cemetery burying fee to \$1,500.00

City of York Mayor Willie Lake asked the council to consider raising the fee to bury

someone in the York Cemetery.

Lake said the fee is currently \$75 to bury in York, which was set over thirty years ago. He said it now costs the city \$1,500 each month to have the cemetery lawn mowed.

Lake presented a list of ceme tery fees for towns in Alabama that ranged from \$1,500 to \$4,000 and suggested raising the burial fee in York.

Following the discussion, a motion was offered and passed to increase the burial fee at the York Cemetery to \$1,500. The motion passed by a vote of 5-1

Councilman Jazmin Mitchell said he felt \$1,500.00 was too much of an increase and voted against it.

an agreement with the Alabama Department of Environmental Management to provide \$225 million in COVID-19 relief funds to ADEM.





Lake said water wells currently "are operating at about fifty percent capacity" and the city spends double the amount it should to maintain the sys-

Alexander said, "If you have a situation where you have to let someone go [fire them], it is good to have things documented in their employee file.

"If you haven't been doing an annual evaluation you will have a problem. They could sue you and get their job back. Those evaluations are important for the employer and the employee,

The proposed Whistleblower Policy read in part:

The City of Livingston encourages its employees to report improper activities in the workplace and will protect employees from retaliation for making any such report in good faith.

1. Employee Rights

Employees have the right to report, without suffering retaliation, any activity by City of Livingston or

any of our employees that the employee reasonably believes: I) violates any state or federal law; "Especially the whistleblower 2) violates or amounts to nonpolicy. Do your employees compliance with a state or fedknow who to go to if there is an eral rule or regulation; or 3) violates fiduciary responsibilities by a nonprofit corporation. In addition, employees can refuse to participate in an activity that would result in a violation of state or federal statutes, or a violation or noncompliance with a state or federal rule or regulation.

Employees are also protected from retaliation for having exer-

The whistleblower protection laws do not entitle employees to violate a confidential privilege of the City of Livingston (such as the attorney-client privilege) or improperly disclose trade-secret information.

2. Where to Report

Employees have the duty to comply with all applicable laws and to assist the City of Livingston to ensure legal compliance. An employee who suspects a problem with legal compliance is required to report the situation(s) to or if the complaint in-

volves the elected person(s). Employees may also report information regarding possible unlawful activity to an appropriate government or law enforcement agency.

3. Protection from Retaliation It is the intent of this policy to encourage employees to report fraudulent or illegal activities and there shall be no retaliation for any reports made pursuant to this policy. Any employee who believes they have been retaliated against for whistle blowing may

file a complaint with either or \_ . Any complaint of retaliation will be promptly investigated and remedial action taken when warranted. This protection from retaliation is not intended to prohibit managers or supervisors from taking action. including disciplinary action, in the ordinary course of business based on valid performance-related fac-

## UWA Tigers run past Hawks with big second half

LIVINGSTON, Ala. - With the de- Battle took over from there carrying fense again coming up with big plays, the offense was able to find the running game once again as the West Alabama football team chewed up 338 vards on the ground and four touchdowns on their way to claiming the 37-14 win over Shorter in Gulf South Conference action Saturday inside Tiger Stadium. It was a three back attack with Bry Webb, Demetrius Battle and Antonio Brown combining for 332 yards and four touchdowns to lead the way. Overall, UWA (3-2, 1-1 GSC) gained 418 yards and held Shorter (2-3, 0-2 GSC) to 215 total yards. The defense collected six sacks and held the Hawks to just 2-18 on third downs. The Tigers used a complete team effort with special teams coming up big as well. Gabriel Dunkle connected on three field goals and Dearrius Nelson returned three kickoffs for 122 yards, including a big 88yard return that helped setup a touchdown.

Right away, special teams came to the forefront when the defense held a quick three-and-out for the Hawks. On the ensuing punt, Caeleb Bass was able to get a piece of the punt for the block, setting up the Tigers at the Shorter 29. Although the drive stalled there, Dunkle came through cashing in from 47 yards out for the field goal and the early 3-0 lead just over two minutes in. His field goal attempt came after Shorter was called for a five-yard running into the punter penalty that allowed UWA to try for three instead of punting.

Shorter briefly took the lead later in the opening quarter. A seven play, 65yard drive was capped off by a 34yard touchdown pass from Aeneas Dennis to Amarey Morrow for the 7-3 lead. Momentum didn't last long for the Hawks, as the ensuing kickoff Nelson caught the return at the UWA four and was able to find a seam up the middle. He then turned towards the far sideline and nearly made it all the way to the end zone before being caught at

the ball three straight times, with the final carry from two yards out finding the end zone for the 10-7 lead. With Battle's touchdown, he now has 21 career rushing scores to move into a tie for the top-10 list in program history. Battle is also now just 189 rushing yards from also entering the top-10 in program history. Following another defensive stop, the Tigers were on the move to start the second quarter. On third-and-nine, Jake Corkren was able to find Darius Nalls who turned the crossing route into a 25-yard gain to move the chains down to the Shorter 11. UWA would turn the 48-yard drive into points with Dunkle hitting from 27 yards out for the 13-7 lead. Neither team was able to generate any offense the rest of the half with UWA taking the 13-7 lead into the locker rooms. It was a big stop by the defense early in the third quarter. After a muffed snap on a punt placed the ball at the UWA 42, the Tiger defense was able to stop the drive inside the 10 forcing a field goal. The field goal attempt from 26 yards missed leaving it a 13-7 lead. Right after that play, UWA took all the momentum and ran away with it - literally. On the next offensive snap, Webb found a seam and was able to go 80 yards for the touchdown to

just past midfield, Arceneaux started the drive with a 22-yard run. Webb then took over with five straight carries, with the last one finding the end zone from 12 yards out to provide the final margin of 37-14.

With the win, UWA has now won all 11 meetings against Shorter. The home win in Livingston also snapped a six-game losing streak at home dating back to last season. The 338 team rushing yards is the most since UWA rushed for 314 yards last season against North American. The last time the Tigers eclipsed 338 rushing yards was back in 2014 going for 473 yards against Concordia and 340 against Shorter in the same season.

Webb ended rushing 15 times for 164 yards and two touchdowns. Brown carried the ball 10 times for 84 yards and a score, while Battle added 18 carries for 84 yards and a touchdown. Arceneaux picked up 46 rushing yards on three carries. Corkren completed 11-28 for 80 yards. Nalls caught three passes for 31 yards, while John Hilbert had four catches for 23 yards. Michael Anderson and Trevon Stanford led the defense with six tackles apiece. Kel Williams and Shamar Lewis added five tackles each. Davonchae Bryant recorded 2.5 sacks, while Jamal Ellis added 1.5. Bryant also had three pass breakups, tipping multiple passes at the line of scrimmage. UWA held Aeneas Dennis to just 10-24 for 93 yards and a touchdown. Harold Cook played a lot in the second half and completed 6-14 for 28 yards. Justus Durrant rushed for 78 yards and a touchdown. John Dickerson caught four passes for 38 yards and Morrow had his one reception for a touchdown of 34 yards. On defense, Debonn Lane and Artellious Edmond came away with nine tackles each. Bryan Rice picked up three tackles for loss and a sack. Following the three straight home games, UWA will now hit the road this coming week as they will play at nationally-ranked Valdosta State with kickoff set for 6 p.m. (Cen-







Never fear, you will not actually be subjected to lengthy presentations of all the Bard's plays. This is, after all, an abridged version. Instead, you are more likely to recognize a line here and there from Shakespeare's varied works. You may glimpse one of the Bard's familiar—and overused-plot twists. All right, the truth is that the show you will see bears very little resemblance whatsoever to the comedies or tragedies of Shakespeare. As a matter of fact, this troupe doesn't even pay tribute to the Elizabethan custom of casting all roles with male actors, choosing instead to cast all roles with female performers. It makes for a particularly interesting rendition of Romeo and Juliet, but you be the judge. Suffice it to say that the actors (UWA students Alaisha Perry, Elizabeth Ward and Janna Williamson) are working very hard to meet the challenge of performing The Compleat Works, but they can't possibly be considered Elizabethan scholars. As you will see, only one of them has even read a couple of books about Shakespeare. The result of their efforts, therefore, is fraught with error which, naturally, results in chaos and hilarity. The Compleat Works of Wllm Shkspr [abridged] is an excellent

primer for the most improper way to stage the works of the Bard; therefore, it is highly recommended to all students of theatre, history and English literature. As a public service to future audiences throughout our area, groups of aspiring thespians, as well as history and literature students—and their teachers or directors—are cordially invited to attend a performance of The Compleat Works free of charge. this illness. Not all cases of monkeypox require treatment, but people with this diagnosis need to isolate and follow infection control measures to reduce transmission of the virus to other people. Direct contact persons of individuals with the illness may benefit from vaccine given within 4 to 14 days of contact. A two-dose vaccination series is available to persons at higher risk. Monkeypox testing continues to be offered at county health departments, and clinical testing is available through the ADPH Bureau of Clinical Laboratories at no charge to the patient. Some commercial and clinical laboratories also test for monkeypox. In addition to education for persons to reduce the risk of monkeypox, ADPH promotes the use of Jynneos vaccine. Selected county health departments in Alabama have Jynneos vaccine in stock, but all local county health departments can provide information about appointments and administer vaccine if persons cannot travel to selected counties. The ADPH monkeypox webpage continues to update information for healthcare providers and the public, including weekly data updates. U.S. Postal Service announces steep postage rate hikes

The United States Postal Service today announced a planned adjustment of postage rates as of August 29, 2021, for the public and commercial mail users. For community newspapers using Periodicals mail to reach readers, the average rate increase will be nearly **9%.** The First-Class Stamp will move from 55 to 58 cents.
